## Artist Ownership & Revenue Share Agreement

This Agreement is entered into as of [EFFECTIVE DATE].

**Between:**

**UNIS MUSIC PLATFORM** ("Unis"), a hyper-local digital music discovery service based in Harlem, New York, and

[**ARTIST NAME**] ("Artist"), an independent creator.

*WHEREAS, Artist is the sole owner of certain sound recordings and musical compositions;*

*WHEREAS, Artist desires to make such works available on Unis for discovery and monetization;*

*WHEREAS, Unis desires to promote independent talent while ensuring Artist retains full ownership of their works;*

*NOW, THEREFORE, the parties agree as follows:*

### 1. Grant of Non-Exclusive License

Artist hereby grants Unis a **non-exclusive**, royalty-free, worldwide license to reproduce, distribute, publicly perform, publicly display, and otherwise use the Uploaded Works (as defined below) on the Unis platform and associated services, including for promotional and advertising purposes. This license is expressly non-exclusive, meaning Artist retains the right to license the same works to any other platform, distributor, or third party without restriction or conflict.

### 2. Ownership Retained by Artist

Artist retains **100% ownership** of all rights in the sound recordings (masters) and underlying musical compositions (publishing). This Agreement does not transfer any ownership rights to Unis. Artist may exploit the Uploaded Works elsewhere without restriction.

### 3. Revenue Share

Unis shall pay Artist **60% of Net Streaming Revenue** attributable to plays of the Uploaded Works. "Net Streaming Revenue" means gross revenue from streams and advertisements attributed to the Uploaded Works, minus platform costs, applicable taxes, and compulsory royalties paid on behalf of Artist to performing rights organizations and mechanical licensing collectives. Unis shall pay such compulsory royalties on Artist's behalf at no additional charge to Artist.

For direct sales of Uploaded Works on the Unis platform, Artist shall retain **85%** of the sale price, with Unis retaining 15% to cover payment processing and platform operating costs. Payment to Artist for direct sales shall be initiated within **two (2) business days** of purchase, subject to standard fraud and chargeback verification.

#### 4. Uploaded Works

The following works are covered under this Agreement and are hereby incorporated by reference. Additional works uploaded by Artist after the effective date shall be appended to this list and shall be subject to the same terms.

#### 5. Artist Warranties & Termination

Artist warrants ownership and/or control of all rights in the Uploaded Works and indemnifies Unis from any third-party claims arising from breach of this warranty. This Agreement is perpetual but **terminable by Artist with thirty (30) days written notice**. Upon termination, Unis shall cease distribution of the Uploaded Works and the license granted herein shall automatically terminate. Artist shall retain all revenue accrued prior to the effective date of termination.

#### 6. No Agency or Representation

Nothing in this Agreement creates an agency, employment, partnership, or joint venture between the parties. Unis does not act as Artist's publisher, label, manager, or agent, and makes no claim to sync licensing, publishing administration, or representation rights.
